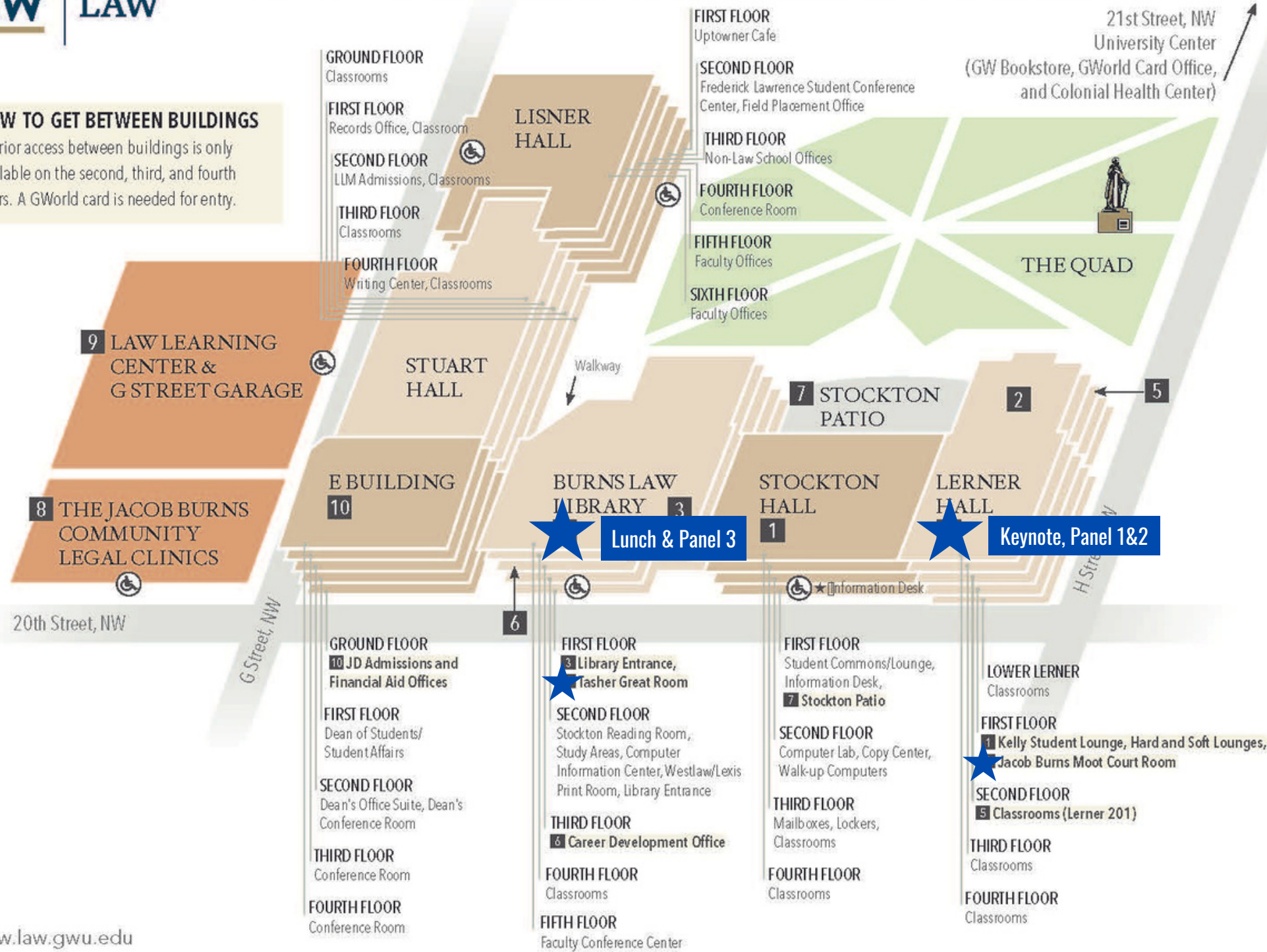


HOW TO GET BETWEEN BUILDINGS
